2. Alterations and repair work determined by the mechanical official to be of a minor nature.
3. Business, mercantile and storage buildings having HVAC equipment only, with one fire area and not more that 3,500 square feet.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

Plans are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA 299 and shall bear that architect's or engineer's seal and signature.

V. Applicant Signature

IX. Instructions for Completing Application

GENERAL: Mechanical work shall not be started until the application for permit has been received the Ogemaw County Building and Zoning Department. All installations shall be in conformance with the State Mechanical Code. No Work shall be concealed until it has been inspected. The office telephone number will be provided on the permit form. When ready for an inspection, call the office providing as much advance notice as possible. Please have the Township and Permit Number when calling.
EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within 180 days after issuance of the permit or if the authorized work is suspended or abandoned for a period of 180 days after the time of commencing the work.
 A permit will be cancelled when no inspections are requested and conducted within 180 days of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.
